Dear Sir,

We, BA & Associates (BijayAgarwal), Company Secretaries (FCS: 10323, CP No.:13549), have been appointed by the Board of Directors of IFB INDUSTRIES LIMITED ("the Company") as the scrutinizer on 2nd November 2023 for the purpose of scrutinizing the postal ballot voting conducted by way of remote evoting process ("e-voting") in a fair and transparent manner on the resolutions as contained in the Postal Ballot Notice dated 2nd November 2023("Notice") issued in accordance with General Circular Nos. 14/2020 dated April 8, 2020 and 17/2020 dated April 13, 2020 read with other relevant circulars, including General Circular No. 10/2021 dated 23 June 2021, issued by Ministry of Corporate Affairs (MCA), Government of India (hereinafter referred to as "MCA Circulars").

1. The said appointment as Scrutinizer is under the provisions of Section 110 of the Companies Act, 2013 ("the Act") read with Rule 20 and Rule 22 of the Companies (Management and Administration) Rules, 2014, as amended ("the Rules"). As the Scrutinizer, we have to scrutinize the process of e-voting conducted for the postal ballot, using an electronic voting system on the dates referred to in the Notice.





2. Management Responsibility

The management of the company is responsible to ensure compliance with the requirements of (i) the act and rule made thereunder; (ii) the MCA Circulars; and (iii) the SEBI (Listing obligations & Disclosure Requirements) Regulation 2015, ("LODR") relating to e-voting on the resolution for ensure a secured framework and robustness of electronic voting systems. The Company has appointed National Securities Depository Limited ("NSDL") (the "Depository") the agency to provide E-voting facilities to the shareholders of the Company from 9:00 A.M. (IST) on Saturday, January 13, 2024 to 5:00 P.M. (IST) on Sunday, February 11, 2024.

3. Scrutinizer's Responsibility

My responsibility as a scrutinizer to ensure for e-voting process is restricted to making a scrutinizer's report of the votes cast "in favour" or "against" by the members in respect of the resolution contained in the notice. My report is based on verification of data and reports generated from NSDL e-voting website http://www.evoting.nsdl.com till the time fixed for closing of the e-voting conducted in a fair and transparent manner and submit scrutinizer's report on the voting to the Chairman of the Company on the resolutions based on the reports generated from the electronic voting process i.e. till 5.00 P.M. IST on Sunday, February 11, 2024 system provided by National Securities Depository Limited("NSDL") (the "Depository")the agency appointed to provide E-voting facilities.

4. Cut-off Date

The member of the company as on the "cut off" as set out in the Notice i.e.,5thJanuary, 2024 were entitled to vote on the resolution set out in the Notice and their voting right were in proportion to their shareholding in the paid-up equity share of the company as on the cut-off date, subject to the provision of articles of association of the company.

5. Remote e-voting process

- a. Theremote e-voting period remained open from 9:00 A.M. (IST) on Saturday, January 13, 2024 to 5:00P.M. (IST) on Sunday, February 11, 2024.
- b. The votes cast during the remote, e-voting were unblocked on Monday, 12th February, 2024 at 11.40 A.M. after the conclusion of e-voting period for



Postal Ballot and was witnessed by two witnesses Mr. Bapan Kheto and Mr. Ankit Agarwal who are not in the employment in the company.

- c.
